## BILL FOR

- Long title. A Law for a Second Amendment of the Akwa Ibom State Revenue Administration Law, 2016 and for other matters connected therewith.
- Commencement. ( )
- Enactment. **BE IT ENACTED** by the Akwa Ibom State House of Assembly as follows –
- Amendment of Revenue Administration Law. 1. The Akwa Ibom State Revenue Administration (Amendment) Law, 2020 is hereby further amended in subsequent Section of this Bill.
- Amendment of Section 14. 2. Section 14 of the Akwa Ibom State Revenue Administration (Amendment) Law, 2020 is hereby further amended by deleting the whole of the said Section 14.
- Amendment of section 83. 3. The Principal Law is hereby further amended by introducing a new Section 83 as follows –
- “Revenue Codes and Rates. Akwa Ibom State Revenue Codes and Rates are as contained in the Schedule to this Law and as may be reviewed by the Board of Internal Revenue Service in line with economic realities, subject to legislative backing”.
4. The old Sections 83 to 86 are renumbered seriatim.
- Short Title and Commencement. 15. This Law may be cited as Akwa Ibom State Revenue Administration (2nd Amendment) Law, 2021, and shall come into force on the 2nd day of April, 2021.
